

**LET JUSTICE ROLL DOWN --
DECLARING SUPPORT FOR THE GREEN NEW DEAL
AND AFFIRMING THE INTERSECTIONALITY OF CLIMATE JUSTICE
WITH ALL JUSTICE ISSUES**

A Resolution of Witness

1 **SUMMARY:**
2

3 This resolution provides Synod with the opportunity to declare its support for [the Green New Deal](#)
4 [Resolution](#)¹ (H. Res. 109) released by Congress on February 7, 2019. The Green New Deal creates an
5 opportunity for the United States to commit to goals and projects that are consistent with the UCC's
6 decades-long advocacy of environmental, racial and economic justice. By declaring its support, Synod
7 will proclaim the intersectionality of climate justice with all justice issues and offer a path of action and
8 hope by which humanity can address the defining moral issues of our time.

11 **BACKGROUND:**
12

13 With the release of [the Green New Deal Resolution](#)² on February 7, 2019, Congress created an
14 opportunity for the United States to commit to goals and projects that are consistent with the UCC's
15 historical (and historic!) advocacy for racial, economic and environmental justice. The Green New Deal
16 aspires to achieve net-zero greenhouse gas emissions, create jobs, provide for a just transition to clean
17 and renewable energy and secure clean air and water.

18 Recognizing that climate change threatens the safety, health, and dignity of ordinary people, the
19 authors of the Green New Deal have made environmental justice the heart of the resolution. The Green
20 New Deal specifically names the "systemic injustices" that disproportionately affect "frontline and
21 vulnerable communities" and provides a list of such communities that would be familiar to anyone who
22 has read UCC justice resolutions over the past many decades: "indigenous communities, communities of
23 color, migrant communities, deindustrialized communities, depopulated rural communities, the poor,
24 low income workers, women, the elderly, the unhoused, people with disabilities, and youth." Indeed, the
25 genius of the resolution is that it identifies and seeks to address two interrelated crises: a climate crisis
26 and a socio-economic crisis of wage stagnation and growing inequality.

27 In compliance with the Standing Rules of General Synod, this resolution is submitted as a so-
28 called Emergency Resolution because the Congressional Resolution itself (H. Res. 109) was not released
29 until February 7, 2019, well past the January 2, 2019, deadline for Standard Resolutions.

32 **BIBLICAL, THEOLOGICAL AND ETHICAL RATIONALE**

43 As people of faith, we recognize that ***the earth is the Lord's...*** Nevertheless, Creation, God's great gift
44 – the context in which all life seeks fulfillment – is in crisis. The scientific consensus is unambiguous.
45 Climate change is real, it's caused by human activity, it's already happening, and it's accelerating. The
46 scale of Creation's demise is dramatically expanding beyond our comprehension.

47

48 The Green New Deal addresses this urgent crisis by offering America a comprehensive ***vision*** that, if
49 implemented, can save millions of lives even as it addresses economic inequalities, environmental
50 racism and other manifestations of climate injustice.

51

52 Our generation still has the power to bend the moral arc of the universe towards justice by reviving
53 creation. Indeed, by acting with the urgency and on the scale of the Green New Deal, we may still have
54 time to avoid the worst consequences of climate change as we seek to preserve God's great gift of
55 creation.

58 **TEXT OF THE MOTION**

59

60 WHEREAS, the Green New Deal is rooted in the scientific findings from the October 2018 [Special](#)
61 [Report from the Intergovernmental Panel on Climate Change](#), which declares that carbon emissions
62 must be reduced by about fifty per cent before 2030 and completely phased out before 2050 if global
63 temperature rise is to be limited to 1.5°Celsius;³

64

65 WHEREAS, humanity is already contending with changes on a scale we can hardly comprehend, such
66 as:

- 67 • Rainfall from big storms is now measured in feet - not inches (e.g., Houston received five feet
68 (61") of rain from Hurricane Harvey).⁴
- 69 • The Earth's temperature is already well into the range that existed during the Eemian period,
70 120,000 years ago, when sea level was 20 to 30 feet higher than it is now.⁵
- 71 • The cost of catastrophic, unprecedented flooding in the Midwest in the spring of 2019 is well
72 over \$3 billion.⁶

- 73 • “Not since World War II have more human beings been at risk from disease and starvation than
74 at this very moment.” Climate change is the primary cause of droughts, which are increasingly
75 rendering areas in Africa uninhabitable.⁷
76 • Recognizing that the sixth mass extinction in geological history is now underway, biologists are
77 using the term “Biological Annihilation” as species are going extinct at at least 100 times the
78 normal rate;⁸

79 WHEREAS, the urgency of the climate crisis is accelerating faster than anyone imagined. For example:

- 80 • In January, 2019, scientists learned that the oceans are warming 40% faster than they had
81 previously thought.⁹
82 • As the oceans absorb CO₂, they are becoming more acidic at a frightening rate in excess of any
83 change the world has seen in 300 million years;¹⁰
84

85 WHEREAS, climate change multiplies and accelerates injustice by hitting the poorest people and people
86 of color first and worst because it’s the poorest people and people of color who typically live in areas
87 most likely to flood, most prone to disease, and most subject to the droughts, heat-waves and various
88 diseases that are now migrating on account of climate change.
89

90 WHEREAS, climate change is creating and accelerating a health crisis in our inner cities that gets worse
91 each summer, especially as rising temperatures create urban heat islands responsible for more and more
92 cases of asthma that are disabling – and killing – children and elderly people of color.
93

94 WHEREAS, those most affected by climate change have not caused it and are powerless to stop it. For
95 example, the farmers in parts of Africa who are losing their lands either to drought or to unprecedented
96 flooding have a carbon footprint that is 1/200th the carbon footprint of the average American;
97

98 WHEREAS, the people and institutions who actually caused and are causing climate change aren’t
99 being held accountable for the catastrophic damage climate change is already causing;
100

101 WHEREAS, the Green New Deal acknowledges the necessity of assuming moral responsibility for
102 intergenerational harm caused by failure to act on climate change and the urgency of taking action on a
103 comprehensive scale to reduce the catastrophe future generations will inherit;
104

105 WHEREAS, on March 15, 2019, more than 1,400,000 young people in 128 countries, in over 2,200
106 cities and towns, and on every continent (including Antarctica) walked out of their schools on a school
107 strike for climate action – the biggest day of global climate action ever – insisting that, in the words of
108 16-year old Greta Thunberg, initiator of the school strike for the climate and Nobel Prize nominee, “We

109 need a whole new way of thinking...we need to start cooperating and sharing the remaining resources of
110 this planet in a fair way”;¹¹

111

112 WHEREAS, in 2017, 97% of Synod delegates acknowledged the profound moral implications of
113 climate change by voting to “declare a new moral era,” and committing to the “moral imperative” of
114 urging “clergy to speak from their pulpits about the moral obligation of our generation to protect God’s
115 creation”;

116

117 WHEREAS, the two interfaith environmental organizations with which the United Church of Christ
118 partners - [Interfaith Power and Light](#) (a national organization with affiliates in almost every state) and
119 [Greenfaith](#) - describe the Green New Deal as “a tangible expression of key values that animate [our]
120 vision of a better world” and as “a profound moral opportunity” because the Green New Deal is
121 informed by truth and science, driven by urgency, far reaching in its scale and comprehensive in its
122 goals;¹²

123

124 WHEREAS, Yale researchers say 81% of the voters they polled support a Green New Deal to create
125 jobs and work toward renewable energy;¹²

126

127 WHEREAS, scores of scientists have spoken out in favor of the Green New Deal, including Stanford
128 Professor Mark Jacobson, whose research demonstrates that each of the 50 states can establish a zero-
129 emissions economy by 2035 and who says, "Right now, we have about ninety per cent or ninety-five per
130 cent of the technology we need.... We don't need a technological miracle to solve this problem. The
131 bottom line is we just need to deploy, deploy, deploy";¹³

132

133 WHEREAS, on February 8, 2019, [the executive leadership of the United Church of Christ endorsed the
134 Green New Deal](#);¹⁴

135

136 WHEREAS, over the past 50+ years the UCC, along with religious leaders from other faiths and
137 denominations, has issued countless statements on the goodness of Creation and our call to act as
138 responsible environmental stewards, all of which has been an insufficient witness;

139

140 WHEREAS, the Core Purpose of the United Church of Christ states (in part): “... we serve God in the
141 co-creation of a just and sustainable world as made manifest in the Gospel of Jesus Christ”; and

142

143 WHEREAS, this historic moment provides Christian communities with a powerful opportunity to bear
144 witness to the sacredness of God’s Creation and the urgent call to preserve it, and responding to this call
145 expresses the new mission initiative of the UCC known as [the three great loves](#), one of which is love of
146 creation;

149 **THEREFORE, BE IT RESOLVED**, that the Thirty-second General Synod of the United Church of
150 Christ, in keeping with numerous resolutions passed by previous General Synods, recognizes the scale
151 and immediacy of the climate crisis, the urgent need to achieve net-zero greenhouse gas emissions as
152 soon as possible, and the moral obligation to embrace the unprecedented socio-economic changes that
153 we must effect and engage **as opportunities** to create fair paying jobs, secure clean air and water,
154 redress manifestations of environmental racism and pursue a just transition to clean and renewable
155 energy.

156
157 BE IT FURTHER RESOLVED, that the Thirty-second General Synod of the United Church of Christ
158 joins [the executive leadership of the United Church of Christ](#)¹⁵ and the United Church of Christ Council
159 for Climate Justice (with representatives from all geographic conferences of the UCC) in endorsing [the](#)
160 [Green New Deal Resolution](#)¹⁶ (H. Res. 109) released by Congress on February 7, 2019.

161
162 BE IT FURTHER RESOLVED, that the Thirty-second General Synod of the United Church of Christ
163 calls upon the whole of the church to accept the moral responsibility that comes with living “at such a
164 time as this” (Esther 4:14) by:

- 165 • Standing up for the critical role science must play in understanding the challenges that now pose
166 an existential threat to life as we have known it on this planet;
- 167 • Continuing to learn from scientifically informed sources about the new realities and new
168 solutions that are emerging every day;
- 169 • Discussing climate change with increasing frequency at church, at home, at work and in our
170 social encounters, emphasizing how it threatens things we all value while noting that we already
171 have all the technology we need¹⁷ to achieve the goals of the Green New Deal;
- 172 • Incorporating into our worship life and community leadership an awareness of climate change,
173 its consequences (especially for vulnerable, frontline communities), and the opportunities we still
174 have to make the changes science says we must and technology says we can;
- 175 • Helping our communities to be more prepared for extreme weather events and more resilient to a
176 changing climate in the long term;
- 177 • Lifting up the reality that many people, regardless of their political affiliation or allegiance,
178 support the Green New Deal because it addresses not only climate change but also numerous
179 forms of injustice;
- 180 • Paying attention as federal, state and local agencies develop and propose new policies that
181 impact our environment and engaging those agencies as advocates for policies and legislation
182 that advance the goals of the Green New Deal, including its commitment to address the
183 “systemic injustices” that disproportionately affect “frontline and vulnerable communities”;
- 184 • Maintaining a commitment to compassion and fairness by advocating for a just transition for
185 those workers and communities most dependent on fossil fuel energy so that they, too, have
186 opportunities for clean, healthful and family-supporting jobs that heal our planet.

187 BE IT FURTHER RESOLVED, that the Thirty-second General Synod of the United Church of Christ
188 calls upon the whole of the church to accept that it is up to us to pour ourselves out to bend the moral arc
189 of the universe towards justice, with joy in our hearts, beauty in our sights, and hope for the children.
